



## **Assumption of Risk and Waiver of Liability** Relating to Coronavirus/COVID-19

Severe acute respiratory syndrome coronavirus 2 (“SARS-CoV-2”), which is responsible for Coronavirus Disease (collectively “COVID-19”), has been declared a worldwide pandemic by the World Health Organization. COVID-19 is highly contagious and is believed to spread mainly from person-to-person contact.

Consistent with San Mateo County Health directives currently allowing operations of youth sports, Pacifica Girls Softball League (the “Organization”), will offer a Spring 2021 softball program as set forth on the Pacifica Girls Softball League website (“2021 Season”). In accordance with the 2021 Season, the Organization has put in place preventative measures (“PGSL 2021 COVID-19 Safety Protocols” available at [www.thePGSL.com](http://www.thePGSL.com)) that are intended to reduce the spread of COVID-19 and minimize the risk of infection to the same; however, the Organization does not and cannot guarantee that you, your child(ren), family, friends or others will not become exposed to, or infected with COVID-19 and/or any mutation or variation thereof while attending or participating in any Organization activities. While the 2021 Season includes best practices from government and health organizations, it is recognized that it cannot reduce the risk of infection to zero.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), myself and others may be exposed to or infected by COVID-19 by participating in, or attending Organization sanctioned and coordinated activities, and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I further understand that the risk of becoming exposed to or infected by COVID-19 during Organization sanctioned or coordinated activities may result from the actions (negligent or not) of myself and others, including, but not limited to, the Organization, its Board, its contractors, its employees, its coaches and other volunteers, and its program participants and their families.

Additionally, by signing this agreement, I voluntarily agree to assume all of the previously mentioned risks and accept sole responsibility for any injury to my child(ren) or myself, illness, death, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)’s participation in Organization activities. On my behalf, and on behalf of my child(ren), I hereby release, pledge not to sue, and hold harmless the Organization, its Board, its contractors, its employees, its coaches and other volunteers, and its agents, of any and all claims, including all liabilities, actions, damages, costs or expenses of any kind arising out of or relating to exposure or contraction of COVID-19 and/or any mutation nor variation thereof. I understand and agree that this release includes any claims based on the actions (negligent or not) of the Organization, its Board, its contractors, its employees, its coaches and other volunteers, and its agents, regardless of whether a COVID-19 infection occurs before, during, or after participation in any Organization activity.
